**Parent/Guardian Permission Form**

In consideration of Pinewood Canoe & Camp LLC furnishing services and /or equipment to enable my child to participate in canoeing, kayaking, swimming, camping or any other activity, I agree as follows: I fully understand and acknowledge that outdoor recreational activities: (a) have inherent risks, dangers and hazards and such exists in use of Pinewood Canoe & Camp LLC equipment and participation in such activities; (b) participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of owners, employees, officers or agents of Pinewood Canoe & Camp LLC; the negligence of the participants, the negligence of others, accidents, breaches of contract, forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to guide decision making, including that a guide may misjudge terrain, weather, trail, or river route location, and water level, risks of falling out of or drowning while in a raft, canoe or kayak and such risks hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment; and (d) participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and /or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of Pinewood Canoe & Camp LLC, or by any other person.

I, on behalf of my child, myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Pinewood Canoe & Camp LLC and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Pinewood Canoe & Camp LLC equipment or my participation in Pinewood Canoe & Camp LLC activities. I specifically understand that I am releasing, discharging and waiving any and all claims or actions that I may have presently or in the future for the negligent acts or conduct by the owners or employees of Pinewood Canoe & Camp LLC. The venue of any dispute that may arise of this agreement or otherwise between the parties to which the Pinewood Canoe & Camp LLC or its agents is a party shall be either the City of Centerville, Tennessee Justice Court or the County or State Supreme Court in Hickman County.

*I have been advised that my child must wear and approved flotation device while in a boat.*

*I have read the above wavier and release and by signing it, agree, it is my intention to exempt and relieve Pinewood Canoe & Camp LLC from liability for personal injury, property damage or wrongful death caused by negligence or any other cause!*
